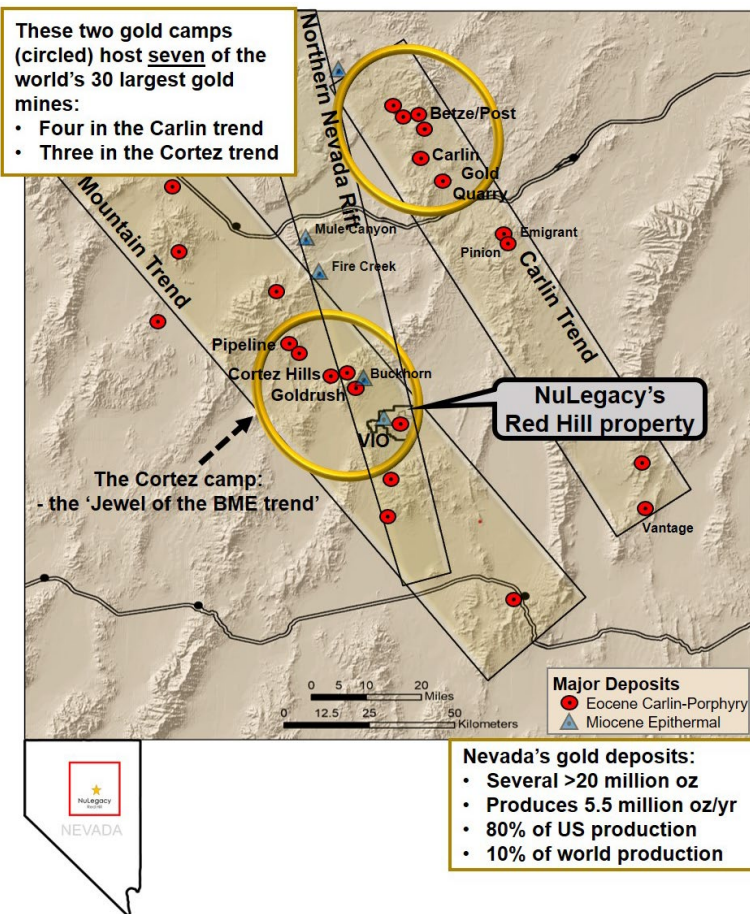




The Opportunity in Nevada

The Cortez Elephants of Nevada

The Cortez Complex hosts three of Barrick Gold's largest, highest grade and politically safest Tier 1 gold deposits in the world.

- A cluster of deposits with multiple horizons:
 - Pipeline ~ 21 million oz @ 2.5 grams
 - Cortez Hills ~ 15 million oz @ 4.1 grams
 - Goldrush ~ 10 million oz @ 10 grams
 - Red Hill ?
- 50 million+ oz gold endowment
- Producing ~1.0 million oz/year at remarkably low AIS-cost of \$624 per ounce of gold¹

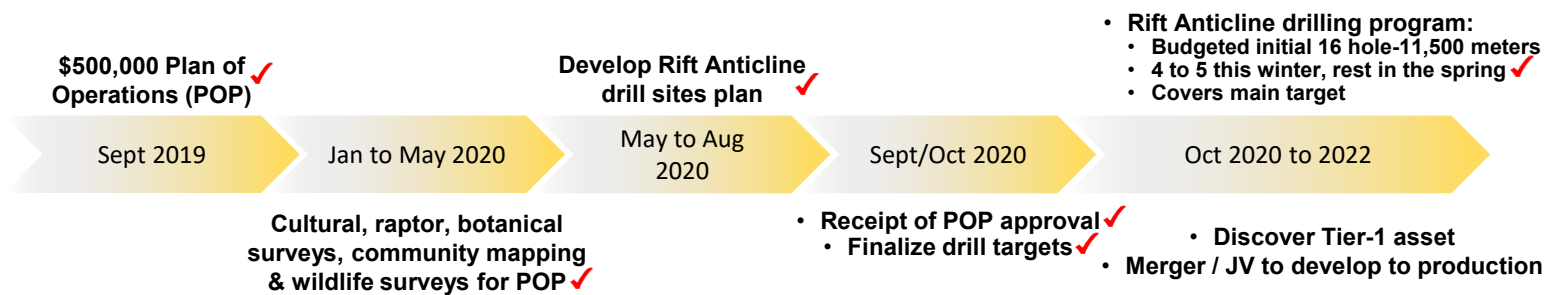
